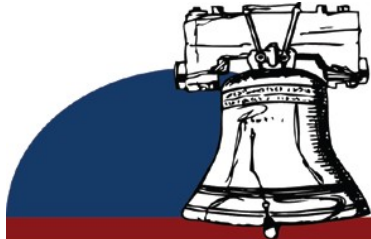

**FEE SCHEDULES**  
**Effective November 1, 2012**

**SECTION 1**

The purpose of this schedule is to establish, regulate, and control permit, inspection, subdivision and planned development plat filing, zoning petition, and other fees related to the Building Inspections Department.

**SECTION 2**

**A. Building Permit Fees**

Fees for buildings and structures, other than manufactured (mobile) homes, signs and fences, shall be determined by dollar valuation totals as listed in the table below. Cost of construction or total dollar valuation shall be determined by the Director of Inspections, and shall be calculated from the cost of construction data published by the International Code Council.

<b>TOTAL VALUATION</b>	<b>FEE</b>
\$100.00 or less	No fee, unless inspection is required, in which case a \$10.00 fee will be charged.
\$101.00 to \$2,000.00	\$10.00 per thousand or fraction thereof.
\$2,001.00 to \$15,000.00	\$20.00 for the first \$2,000.00, plus \$5.00 for each additional thousand or fraction thereof, to and including \$15,000.00.
\$15,001.00 to \$50,000.00	\$85.00 for the first \$15,000.00, plus \$4.50 for each additional thousand or fraction thereof, to and including \$50,000.00.
\$50,001.00 to \$100,000.00	\$242.50 for the first \$50,000.00, plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000.00.
\$100,001.00 to \$500,000.00	\$442.50 for the first \$100,000.00, plus \$3.50 for each additional thousand or fraction thereof, to and including \$500,000.00.
\$500,001.00 and up	\$1,842.50 for the first \$500,000.00, plus \$3.00 for each additional thousand or fraction thereof.

## SECTION 2 Cont'd

### B. Super Permit Building Fees

Single-family residential building projects that reach a minimum, threshold valuation of \$50,000.00 will be issued a Super Permit. This Super Permit will be issued to the General Contractor and will include all structural, plumbing, electrical (including temporary service poles located on that lot), and mechanical work. Individual trade permits will not be issued for these projects.

TOTAL VALUATION	FEES
\$50,001.00 TO \$100,000.00	\$384.00 for the first \$50,000.00, plus \$4.50 for each additional thousand or fraction thereof, to and including \$100,000.00.
\$100,001.00 to \$500,000.00	\$609.00 for the first \$100,000.00, plus \$4.00 for each additional thousand or fraction thereof, to and including \$500,000.00.
\$500,001.00 & above	\$2,209.00 for the first \$150,000.00 plus \$3.50 for each additional thousand or fraction thereof.

## SECTION 3

### Other Fees

A. Permit fees for manufactured (mobile) home installation and temporary construction trailers shall be \$75.00.

B. Permit Fees for Signs:

1. For new permanently erected signs, including billboards, the fee shall be \$50.00 per sign.
2. A separate fee of \$25.00 shall be charged for each face of an existing sign or existing billboard sign that displays a different or separate advertising message.
3. For temporary signs, the fee shall be at no cost.

C. Moving of Buildings or Structures:

1. The fee for moving any building or structures, other than manufactured (mobile) homes, signs, or fences, shall be \$50.00.

D. Demolition of Buildings or Structures:

1. The fee for demolition of any building or structure other than manufactured (mobile) homes, signs, or fences, shall be \$50.00.



## **SECTION 3 Cont'd**

### **E. Driveway Permit Fees:**

1. The fee for driveway permits shall be \$30.00.

### **F. Residential Roofing Permit Fees:**

1. The fee for residential roofing permits shall be \$40.00.

### **G. Business License Inspections:**

1. A fee of \$30.00 shall be charged on all business license inspections other than the initial business being located in a newly finished building.

### **H. Re-inspection Fee:**

1. A fee of 50.00 will be charged if a re-inspection is required, examples: not able to inspect job, job not ready for inspection, or third inspection required on same code violation, etc.

### **I. Fees for any other construction work:**

1. Fees for any other construction work i.e; road and curb cuts etc., which is not established in this schedule shall be determined by the Director of Inspections.
2. A fee of \$20.00 will be charged for the placement or construction of all fences within the City Limits of Hinesville.

### **J. Plan Checking Fees.**

1. When the valuation of the proposed construction exceeds \$1,000.00, and a plan is required to be submitted by the Director of Inspections, a plan checking fee shall be paid. Said plan checking fee shall be equal to one half of the building permit fee.

### **K. Payment of fees:**

1. All fees shall be paid prior to the permit being issued. No inspections shall be conducted prior to the fees being paid and the permit being issued, unless prior approval is obtained from the Director of Inspections.

## **SECTION 4**

### **Starting Work Without a Permit**

Where work for which a permit is required is started prior to obtaining the required permit, the fees herein specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of the Building Code in the execution of the work nor from any other penalties prescribed in the City of Hinesville Code of Ordinances.

## SECTION 5

### Electrical Permit and Inspection Fees

#### A. Permit Fee

A fee of \$20.00 shall be charged for issuing each permit.

**Electrical Permit and Inspection Fees**

C. Re-inspections:

If a re-inspection is required, an additional \$50.00 will be charged.

D. Other Fees:

Fees for any other wiring which is not established in this schedule shall be determined by the Director of Inspections.

1. Power Release Inspections are required by Georgia Power if a property's electrical service has been disconnected for over one year. A fee of \$30.00 shall be charged.

E. Working Without a Permit:

When work for which a permit is required is started prior to obtaining the permit, the fees shall be doubled, but the payment of such doubled fee shall not relieve any person(s) from fully complying with the requirements of the State Electrical Code nor from any penalties prescribed in the City of Hinesville Code of Ordinances.

F. Payment of Fees:

All fees shall be paid prior to the permit being issued. No inspections shall be conducted prior to the fees being paid and the permit being issued.

## SECTION 6

### Gas Permits and Inspection Fees

A. Permits:

A base permit of \$20.00 shall be charged for issuing each permit.

B. Inspection Fees:

(1) 1 to 4 Outlets: \$5.00 plus \$2.00 for each additional outlet over 4.

(2) Conversion burners, floor furnaces, incinerators, boilers, central heating or air conditioning units:  
\$5.00 for one (1) unit plus \$2.00 for each additional unit.

(3) Wall furnace, water heater: \$2.50 for one (1) unit plus \$2.00 for each additional unit.

C. Re-inspection Fees:

If a re-inspection is required, an additional fee of \$50.00 will be charged.

D. Other Fees:

Fees for any other gas work which is not established in this schedule shall be determined by the Director of Inspections.

E. Working Without a Permit:

When work for which a permit is required is started prior to obtaining the permit, the fees shall be doubled, but the payment of such doubled fee shall not relieve any persons from fully complying with the requirements of the State Gas Code nor from any penalties prescribed in the City of Hinesville Code of Ordinances.

F. Payment of Fees:

All fees shall be paid prior to the permit being issued. No inspection shall be conducted prior to the fees being paid and the permit being issued. A base permit fee of \$20.00 shall be charged for issuing each permit.

## **SECTION 7**

### **Mechanical Permit and Inspection Fees**

**A. Permits.**

A fee of \$20.00 shall be charged for issuing each permit.

**B. Inspections Fees.**

1. The fee for inspection heating, ventilating, ductwork, air conditioning, and refrigeration systems shall be \$10.00 for the first one thousand dollars, or fraction thereof, of valuation of the installation plus \$3.00 for each additional thousand dollars or fraction thereof.

2. The fee for inspecting repairs, alterations, and additions to existing systems shall be \$5.00 for the first one thousand dollars or fraction thereof, plus \$3.00 for each additional thousand dollars or fraction thereof.

3. Boilers (based of BTU input):

33,000 BTU (1 BHP) to 165,000 BTU (5 BHP)	\$10.00

**C. Re-inspection Fees:**

If a re-inspection is required, an additional fee of \$50.00 will be charged.

**D. Other Fees:**

Fees for any other mechanical work which is not established in this schedule shall be determined by the Director of Inspections.

**E. Working Without a Permit:**

When work for which a permit is required is started prior to obtaining the permit, the fees shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of the State Mechanical Code nor from penalties prescribed in the City of Hinesville Code of Ordinances.

**F. Payment of Fees:**

All fees shall be paid prior to the permit being issued. No inspection shall be conducted prior to the fees being paid and the permit being issued.

## **SECTION 8**

### **Plumbing Permits and Inspection Fees**

**A. Permits:**

A fee of \$20.00 shall be charged for issuing each permit.

**B. Inspections Fees:**

Fees for any other plumbing work which is not established in this schedule shall be determined by the Director of Inspections.

**E. Working Without a Permit:**

When work for which a permit is required is started prior to obtaining the permit, the fee shall be doubles, but the payment of such double fee shall not relieve any persons from complying with the requirements of the State Plumbing Code nor from penalties prescribed in the City of Hinesville Code of Ordinances.

**IMPORTANT NOTICE**  
**Topics Related to Private Property Trespass Towing**

**Abandon Vehicle Notification Laws:**

It is the responsibility of the Commission to ensure that all known owners of vehicles removed from private property are notified of the location and the associated impoundment cost of a vehicle removed from private property. The notification requirements are outlined in O.C.G.A. Title 40, Chapter 11 and it is the responsibility of the wrecker service to ensure compliance and understand the requirements. Upon request, wrecker services will be required to provide proof of proper notification for any vehicle in question.

After the first seventy two (72) ours of impoundment, wrecker services may charge up to \$40.00 for the cost of notification. After 30 days, the process outlined in O.C.G.A. Title 40, Chapter 11 applies, which entitles the wrecker service to all reasonable fees connected with the removal or storage plus the cost of any notification or advertisement.

**Surveillance of Private Property:**

It is illegal to enter into any agreement to provide automatic or systematic surveillance of a property for the purpose of removing trespassing vehicles or property. O.C.G.A. §44-1-13(f) states that towing companies must be **called** by the property owner or authorized agent for **each** individual case of trespass. It is the Commission's suggestion that wrecker services have the property owner's agent sign a statement or invoice authorizing the removal.

Automatic or systematic surveillance would include the following:

- Any agreement, verbal or written, to drive through a property and remove any vehicle which has been tagged with a warning or a notice by the property owner/agent *unless the wrecker service has been contracted to remove the vehicle.*
- Any agreement, verbal or written, to drive through a property and tag certain vehicles with warning notices (such as vehicles without property parking decals, invalid tags, etc.) and remove the vehicle after the warning has expired. *Only the property owner/agent can identify vehicles for removal.*
- Any Power of Attorney or contract between the wrecker service and the property owner/agent to automatically remove vehicles parked on the premises of an abandon or vacant property *without being contracted by the property owner/agent.*
- Entering a restaurant or other place of business, asking the patrons to identify their vehicles, and then impounding any vehicle not claimed by a patron or employee.
- Impounding any vehicle left in the parking lot after business has closed its doors for the evening.
- Having an agreement with an employee of a business, who has not been authorized by the property owner (clerk, security guard, waitress, etc.) to contact you for when they observe a possible trespassing vehicle.

### Part 1 Chapter

- Section 20 Municipal Court. Violation of City Ordinances and regulations, bylaws and laws could result in a fine not to exceed **\$500.00**

### Code of Ordinances Chapter 1 General Provisions

- Section 1-12 General Penalty. Violation of any Code and if no specified penalty is provided, individual may be fined not to exceed **\$1000.00**

### Chapter 2 Administration

- Section 2-247 Surety Bonds: The following named officers of the City shall each give a good and sufficient surety bond to the City for **\$5000.00** (The Mayor & Mayor Pro Tem)
- Section 2-251 (b) Immunity of City not waived. Nothing in this section shall be construed to constitute any waiver by the City of the governmental immunity afforded it under the laws and constitution of the State, except as specifically set forth in this section. This section shall not apply to those claims or judgments for damages of **\$25,000.00** or less that are authorized pursuant to this chapter and which constitutes a waiver of governmental immunity only up to such amount.
- Section 2-251 (h) Payments of judgments or monetary settlements.
  - (1) Payments on behalf of officers or employees in satisfaction of any judgment or as a monetary settlement of any pending litigation shall not exceed the total amount of **\$2,000.00** for any and all civil actions instituted as the result of any single or continuing incident or occurrence.
  - (3) No sum in excess of **\$25,000.00** shall be paid pursuant to this section for damages on account of bodily injury, death or property damage arising from the ownership, maintenance, operation or use of any motor vehicle by the City under its management, control or supervision, as provided for in this chapter

### Chapter 4 Animals and Fowl

- Section 4-11 Impoundment of animals running at large. (f) If the court determines that a violation of this section has occurred and the animal is not registered within the meaning of section 4-37, then the minimum fine will be \$10.00. If it is determined that the animal is registered within the meaning of section 4-37, then the minimum fine shall not be less than **\$5.00**, but in no instance shall the fine be more than **\$50.00**.
- Section 4-78 Requirements for possession of dangerous or potentially dangerous dog. (4) The owner of a dangerous dog shall maintain at all times either a policy of insurance or a surety bond in a minimum amount of **\$15,000.00** to cover claims for any personal injuries inflicted by the dog, which policy or surety bond shall be issued by an insurer or surety, as the case may be, authorized to transact business in this state

## City Code Violation: Fire Schedule Cont'd

### Chapter 5 Buildings and Building Regulations

- Section 5-287 Penalties for violation. Violation of the provisions of this article or failure to comply with any of its requirements, including violation of conditions and safeguards established in connection with grants of variance or special exceptions, shall constitute a misdemeanor. Any person who violates this article or fails to comply with any of its requirements shall, upon conviction thereof, be fined not more than **\$250.00** or imprisoned for not more than 30 days, or both, and in addition shall pay all costs and expenses involved in the case.

### Chapter 6 Drainage, Soil Erosion and Sediment Control

- Section 6-27 Civil penalties. Any person violating any provision of this chapter, permitting conditions or stop work order shall be liable for a civil penalty of not less than **\$100.00** per day nor more than **\$500.00** per day, by sentence of imprisonment not exceeding 60 days in jail, or both fine and jail. Each day the violation continues shall constitute a separate offense.
- Section 6-122 (b) Application/permit process. (5)When reviewing any application for a land disturbing activity permit, the issuing authority shall consider the past record of the permit applicant in complying with previous land disturbing activity permits and this article. If the applicant has had two or more violations of previous permits or this article within three years prior to the date of the filing of the application under consideration, the issuing authority may require the applicant to post a bond up to, but not exceeding, **\$3,000.00** per acre of the proposed land disturbing activity prior to issuing the permit.
- Section 6-132 Penalties (d) Monetary Penalties.
  - (1) Except as provided in paragraph (2) of this subsection, any person who violates any provisions of this article, the rules and regulations adopted pursuant hereto, or any permit condition or limitation established pursuant to this article or who negligently or intentionally fails or refuses to comply with any final or emergency order of the Director issued as provided in this ordinance shall be liable for a civil penalty not to exceed **\$2,500.00** per day. For the purpose of enforcing the provisions of this article, notwithstanding any provisions in any City Charter to the contrary, municipal courts shall be authorized to impose a penalty not to exceed **\$2,500.00** for each violation. Notwithstanding any limitation of law as to penalties which can be assessed for violations of county ordinances, any magistrate court or any other court of competent jurisdiction trying cases brought as violations of this article under County ordinances approved under this article shall be authorized to impose penalties for such violations not to exceed **\$2,500.00** for each violation.
  - (2) The following penalties shall apply to land-disturbing activities performed in violation of any provision of this article, any rules and regulations adopted pursuant hereto, or any permit condition or limitation established pursuant to this article;
    - A. There shall be a minimum penalty of **\$250.00** per day for each violation involving the construction of a single family dwelling by or under contract with the owner for his or her own occupancy; and

## City Code Violation: Fire Schedule Cont'd

- B. There shall be a minimum penalty of **\$1,000.00** per day for each violation involving land-disturbing activities other than as provided in subsection of this paragraph

### Chapter 9 Licensing and Business Regulations

- Section 9-96 Circuses, carnivals, and public exhibitions. (d) Conditions of issuance (3) The applicant has placed on file with the City Clerk a certificate or certificates of insurance indicating that there is in effect public liability insurance covering any damage arising out of the use and operation of any and all devices and facilities operated in connection with such carnival or exhibition. Such insurance shall be in the minimum amount of **\$100,000.00** for each person, and **\$300,000.00** for each accident.
- Section 9-99 Health Club business (j) Penalty for violation. There shall be a **\$250.00** fine levied against each violation of the rules and regulations set up in this section
- Section 9-101 Wrecker Service operations (d) Operation requirements.
  - (2) Prior to the issuance of the license required by this section and prior to the conduct of any such operations by said wrecker service, such wrecker service shall obtain and cause to be kept in force at all times during the term of any such license granted under this section, liability insurance issued by a company of sound and adequate financial responsibility of the following types and minimum amounts:
    - Public Liability Insurance
      - Bodily injury- **\$300,000.00** per person
      - \$500,000.00** per occurrence
      - Property Damage- **\$300,000** per accident
    - Garage Keepers Legal Liability Insurance
      - Light duty Wrecker- **\$50,000.00**
      - Heavy duty Wrecker- **\$100,000.00**

### Chapter 11 Nuisances

- Section 11-153 Penalty. It shall be unlawful for any person to violate any provision of this article, or fail to comply therewith, or with any of the requirements thereof. Each such person shall be considered guilty of a separate offense for each and every violation of any of the provisions of this article committed or continued, and shall, upon conviction of any such violation, be punished as follows:
  - (1) For a first violation, a fine of **\$250.00**, or imprisonment for a term not exceeding 30 days or both;
  - (2) For a second violation within any 12-month period, a fine of **\$500.00** or imprisonment for a term not exceeding 60 days;
  - (3) For the third violation within any 12 month period, a fine of **\$750.00**, imprisonment for a term not exceeding 90 days; and

## City Code Violation: Fire Schedule Cont'd

- (4) For any fourth and subsequent violation within any 12-month period, a fine of **\$1,000.00**, or imprisonment of 180 days

### Chapter 12 Offenses and Miscellaneous Provisions

- Section 12-69 Smoking in public facilities (i) Violations and penalties (1) A person who smokes in an area where smoking is prohibited by the provisions of this section shall be guilty of an infraction, punishable by a fine not less than **\$50.00**, but no more than **\$100.00** per offense. (2) A person who owns, manages, operates, or otherwise controls a public facility and who fails to comply with the provisions of this section shall be guilty of an infraction punishable by
  - (A) A fine not exceeding **\$100.00** for a first violation
  - (B) A fine not exceeding **\$200.00** for a second violation within one year; or
  - (C) A fine not exceeding **\$500.00** for each additional violation within one year.
  -
- Section 12-219 Juvenile Curfew (g) (1) For any offense by a parent, the parent shall be subject to a fine not to exceed **\$500.00**. (4) For any offense by a 17 year old juvenile, the 17 year old shall be subject to a fine not to exceed **\$500.00** (5) For an operator of an establishment violates this subsection, the operator shall be subject to a fine not to exceed **\$500.00**.

### Chapter 13 Solid Waste Management

- Section 13-24 Penalty for violation. Any person violating this article may be held liable in damages, and the recovery shall be in a sum of not less than **\$110.00**, not more than **\$550.00** for each violation.

### Chapter 14 Streets, Sidewalks and other Public Places

- Section 14-93 Violations. Whenever in this article any act is prohibited or is made or declared to be unlawful or an offense, or whenever herein the doing of an act is required or the failure to do nay act is declared to be unlawful, the violation of such provision shall be an ordinance violation punishable by a fine of at least **\$500.00**, not to exceed **\$1,000.00**

### Chapter 15 Taxation and Revenue

- Section 15-1 Malt beverage excise tax.
  - (1) Where malt beverages, commonly known as tap or draft beer, are sold in or from a barrel or bulk container, a tax of **\$6.00** on each container sold containing not more than 15 ½ galloons and a proportionate tax at the same rate on all fractional parts of 15 ½ galloons
  - (2) Where malt beverages are sold in bottles, cans or other containers, except barrel or bulk containers, except barrel or bulk containers, a tax **\$.05** per 12 ounces and a proportionate tax at the same rate on all fractional parts of 12 ounces
- Section 15-2 Distilled spirits and wine excise tax (a) Rate of levy. Except where exempted by law, there is hereby set and levied on the distilled spirits and wine an excise tax in the sum of **\$0.22** per liter or fraction thereof.



## City Code Violation: Fire Schedule Cont'd

- Section 15-82 Penalty for article violation (a) It shall be unlawful for any person to violate a provision of this article, or fail to comply therewith, or with any of the requirements thereof. Upon conviction of any such violation such person shall be fined not more than **\$500.00**.
- Section 15-84 Financial institutions; levy of tax (b) The minimum annual amount of business license tax due from any depository financial institution pursuant to this section shall be **\$1,000.00**

### Chapter 16 Traffic

- Section 16-129 Offenses and penalties (e) Any person violating subsections of this section shall be punished by a fine of not less than **\$100.00** and not more than **\$500.00**.

### Chapter 17 Trees and Vegetation

- Section 17-2 Timber harvesting requirements for activities constituting forestry land management practices or agricultural operations. (d) The notice shall not be or remain effective for such harvesting operations unless and until the person or firm providing such notice has delivered to the City Manager or designee a valid surety bond, executed by surety corporation authorized to transact business in this State, protecting the City against any damage caused by such person or firm in an amount specified by the City Council not exceeding **\$5,000.00** (f) Violation of the notice requirements of this section shall be punishable by a fine not exceeding **\$500.00**

### Chapter 18 Vehicle for Hire

- Section 18-26 Accidents. All accidents arising from or in connection with the operation of any taxicab which results in death or injury to any person, or in damage to any vehicle of to any property in an amount exceeding the sum of **\$100.00** shall be reported to the Chief of Police in writing within 24 hours from the time of occurrence

### Chapter 19 Water and Sewer

- Section 19-197 Inspection and enforcement (2) For a second violation, water service shall be terminated and upon correction of the nonconforming condition or activity a reconnect fee of **\$100.00** will be charged. (3) For all subsequent violations, water service shall be terminated and upon correction of the nonconforming condition or activity, a reconnect fee of **\$500.00** will be charged.
